SUB: SAFETY OF CHILDREN IN SCHOOLS – REG.

This is in continuation to the Board's Circular nos.19/2017 dated 12.09.2017 and 21/2017 dated 28.09.2017 vide which extensive guidelines in connection with the safety of school children were circulated for information of all the affiliated schools. A number of additional measures 4 (a, b, c, d, e, f, g and h) were directed to be strictly followed by circular no 19/2017 dated 12/09/2017.

It is further to inform all the schools that the following comprehensive guidelines have been issued by Statutory Bodies of Government of India namely **National Commission for Protection of Child Rights (NCPCR)** and **National Disaster Management Authority (NDMA)** considering the requirement of safety of children in schools covering all essential aspects of safety of children. The additional measures mentioned in CBSE circular dated 12/09/2017 have been adequately covered in the guidelines of NCPCR and NDMA. The schools are therefore required to comply with the guidelines contained in the comprehensive safety guidelines issued by NCPCR and NDMA in respect of the additional measures mentioned in circular dated 12/09/2017 also.

Further, in the light of comprehensive guidelines issued by NCPCR and NDMA there is no requirement at present to issue any further guidelines and accordingly circular no 21/2017 dated 28/09/2017 is hereby withdrawn. The schools may follow the direction given in the comprehensive guidelines issued by NCPCR & NDMA and submit compliance of these guidelines in the manner prescribed in these guidelines or as directed by the concerned State Governments.
